and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Marion County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 14, at page 357; that the priority of the right thereby confirmed dates from 1891

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 304 gallons of water per minute if available at the original point of diversion, and shall be further limited to a diversion of not to exceed one-eightieth cubic foot per second or its equivalent and $2\frac{1}{2}$ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The point of diversion is located in the $SE\frac{1}{4}$ $SE\frac{1}{4}$, as projected within J. Herren DLC 60, Section 18, T8S, R2W, WM: 1,140 feet North and 4,850 feet East from SW Corner, Section 18.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

17.0 acres Lot 4 (NW1/4 SE1/4)

3.2 acres NW4 SE4 as projected within J. Herren DLC 60

2.0 acres Lot 5 (SW4 SE4)

13.2 acres SW4 SE4 as projected within J. Herren DLC 60

24.4 acres $SE\frac{1}{4}$ $SE\frac{1}{4}$ as projected within J. Herren DLC 60 Section 18

Township 8 South, Range 2 West, WM

This certificate is issued to confirm changes in use, place of use and point of diversion approved by an order of the Water Resources Director entered on January 19, 1956, and together with Certificate of Water Right recorded at page 51351, Volume 46, State Record of Water Right Certificates, supersedes the certificate recorded at page 14836, Volume 12, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
