for the purpose of

under Permit No. 26731 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

January 29, 1960 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.36 cubic feet per second measured at the points of diversion; being 2.16 cfs from North Fork Crooked River and 0.20 cfs from Committee Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $NE\ 1/4$ SW 1/4, Section 14, $NW\ 1/4$ NW 1/4, Section 23, $SE\ 1/4$ NE 1/4, Section 22, T16S, R21E, WM; Diversion 1 - 1,820 feet North and 2,670 feet East; Diversion 2 - 880 feet South and 30 feet East; Diversion 3 - 2,310 feet South and 590 feet West, all from the NW Corner, Section 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre.

or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year

conform to such reasonable rotation system as may be ordered by the proper state officer.
