CERTIFICATE OF WATER RIGHT

This Is to Certify, That

RUSSEL J. HUDSON

of 11405 Redwood Highway, Wilderville , State of Oregon 97543 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Slate Creek and spring

a tributary of Applegate River irrigation of 2.3 acres

for the purpose of

under Permit No. 37624 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

February 20, 1973
that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second, being 0.03 cfs from Slate Creek and 0.01 cfs from spring and water to be diverted for irrigation from Slate Creek when available with any deficiency in the available supply from Slate Creek to be made up by * or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW 1/4 SE 1/4, Section 9, T37S, R7W, WM; Creek - 660 feet North and 1,240 feet East; Spring - 410 feet North and 1,000 feet East, both from S 1/4 Corner, Section 9

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre. or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

* appropriation of not to exceed 0.01 cfs from spring provided that the total quantity diverted from both sources not exceed 0.03 cfs

In processing the application toward issuance of the permit, it appears that a clerical error was inadvertently made in limiting the duty of water to not exceed one-eightieth of one cubic foot of water per second per acre and 2 1/2 acre-feet per acre. In the issuance of this certificate, the duty of water has been raised to one-eightieth of one cfs per acre and 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, in keeping with the customary policy and determination of this office of the proper maximum limits.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board
