CERTIFICATE OF WATER RIGHT

This Is to Certify, That JAMES P. AND JOAN T. PETTY

of Route 1, Box 110, Joseph, State of Oregon 97846, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Prairie Creek

a tributary of Wallowa River for the purpose of supplemental irrigation of 259.2 acres

under Permit No. 32467 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from March 29, 1967 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 6.48 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NE 1/4, Section 22, NW 1/4 SE 1/4, Section 15, T2S, R45E, WM; Diversion 1 - 680 feet South and 3,770 feet East; Diversion 2 - 1,350 feet North and 2,870 feet East, both from SW Corner, Section 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 42.2 acres SW 1/4 SW 1/4
- 10.6 acres SE 1/4 SW 1/4

- 21.0 acres SW 1/4 NW 1/4
- 10.8 acres SE 1/4 NW 1/4
- 22.4 acres NE 1/4 SW 1/4
- 38.2 acres NW 1/4 SW 1/4
- 0.6 acre NW 1/4 SE 1/4


