# CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ROY HATHAWAY

of Route 3, Box 393-A, Corvallis , State of Oregon 97330 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Willamette River

a tributary of Columbia River irrigation of 195.4 acres

for the purpose of

under Permit No. 40045 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 23, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.44 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (SW 1/4 NE 1/4), Lot 1 (NE 1/4 NW 1/4), Section 31, Lot 6 (SE 1/4 SW 1/4), Section 30, T12S, R4W, WM; 4 - 2,790 feet North and 2,580 feet East from SW Corner, Section 31, 5 - 3,000 feet South and 200 feet West, 6 - 2,060 feet South and 690 feet West both from C 1/4 Corner, Section 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.
