## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of PO Box 187, Bella Vista , State of California 96008 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Fork John Day River

a tributary of John Day River irrigation of 22.0 acres

for the purpose of

under Permit No. 8731 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 15, 1928

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.10 cubic foot per second, if available at the original point of diversion; NW 1/4 NE 1/4, Section 24, T13S, R26E, WM; Cummings Ditch - 1,200 feet South and 2,650 feet East from NW Corner, Section 24

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $\,$  NE 1/4 NW 1/4, SW 1/4 NW 1/4, Section 18, T13S, R26E, WM; Diversion 2 - 1,020 feet South and 1,880 feet East; Diversion 1 - 1,640 feet South and 420 feet East both from the NW Corner, Section 18

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered September 20, 1974, and supersedes Certificates of Water Right recorded at pages 20223 and 20224, Volume 14, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
