CERTIFICATE OF WATER RIGHT

This Is to Certify, That

GLENN BIRDSEYE

of 3793 Rogue River Highway, Gold Hill, State of Oregon 97525, has
a right to the use of the waters of Birdseye Creek

a tributary of Rogue River for the purpose of
irrigation of 59.0 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 4, at page 1; that the priority of the right
thereby confirmed dates from 1855

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed
0.85 cubic foot per second

The point of diversion is located in the SW 1/4 SE 1/4, Section 34, Township 36 South,
Range 4 West, WM, Birdseye Ditch - 80 feet North and 1110 feet East from S 1/4
Corner, Section 34

A description of the place of use under the right, and to which such right is appurtenant, is as
follows: 0.2 acre SW 1/4 SW 1/4 as projected within F. Birdseye DLC 37
Section 26

1.1 acres SW 1/4 NE 1/4 as projected within D. Birdseye DLC 41
1.5 acres NE 1/4 SW 1/4 as projected within D. Birdseye DLC 41
20.8 acres NW 1/4 SE 1/4 as projected within D. Birdseye DLC 41
0.3 acre Lot 13 (NW 1/4 SE 1/4)
16.7 acres SW 1/4 SE 1/4 as projected within D. Birdseye DLC 41
10.3 acres SE 1/4 SE 1/4 as projected within D. Birdseye DLC 41
0.4 acre SE 1/4 SE 1/4 as projected within F. Birdseye DLC 37
Section 27

7.7 acres NE 1/4 NE 1/4 as projected within D. Birdseye DLC 41
Section 34
Township 36 South, Range 4 West, WM

Resources Director entered February 20, 1970, and is issued to confirm a
change in place of use approved by the same order.


The issuance of this superseding certificate does not confirm the status of
