CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** A. C. HOTCHKISS

of Lakeview, State of Oregon 97630, has  
a right to the use of the waters of Crooked Creek, Juniper Creek and Willow Creek

a tributary of Chewaucan River for the purpose of  
irrigation of 2,495.6 acres domestic and stock

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for  
Lake County, and the said decree entered of record at Salem, in the Order Record of  
the WATER RESOURCES DIRECTOR, in Volume 5, at page 1; that the priority of the  
right thereby confirmed dates from 1890

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an  
amount actually beneficially used for said purposes, and shall not exceed  
a rate of diversion of 1/25th of a cubic foot per second per acre, and the  
aggregate quantity set forth in connection with each tract described below and  
shall be limited to 3.9 acre-feet per acre during each irrigation season,  
being the period from January 1 to September 30 of each year.  
The point of diversion is located in the Heryford Ditch



*And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
