CERTIFICATE OF WATER RIGHT

This Is to Certify, That HAROLD E. RICE

of Route 2, Box 272, Eugene, State of Oregon 97401, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Fall Creek

a tributary of Middle Fork Willamette River for the purpose of irrigation of 54.8 acres

under Permit No. 26502 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 23, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.685 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 30, T18S, R1W, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.9 acre NE $\frac{1}{4}$ SW $\frac{1}{4}$	17.0 acres NE $\frac{1}{4}$ NW $\frac{1}{4}$
0.4 acre SW $\frac{1}{4}$ SW $\frac{1}{4}$	Section 31
36.5 acres SE $\frac{1}{4}$ SW $\frac{1}{4}$	Township 18 South, Range 1 West, WM
Section 30	


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 32662, Volume 24, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on January 11, 1983.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
