CERTIFICATE OF WATER RIGHT

This Is to Certify, That L. J. BALES

of Fisher, State of Oregon, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Buck Creek

a tributary of Five Rivers for the purpose of irrigation of 20.3 acres

under Permit No. 13256 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 30, 1938 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.82 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SE 1/4, SE 1/4 NW 1/4, Section 10, T15S, R10W, WM; Diversion 1 - 3,520 feet South and 350 feet East; Diversion 2 - 840 feet South and 70 feet West both from NW Corner SW 1/4 NE 1/4, Section 10

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/25 of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion at the stream of not to exceed 1 acre-foot per acre for each acre irrigated during any 30-day period and shall be limited still further to a diversion at the stream of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

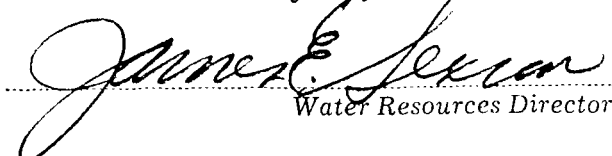
This certificate is issued so as to correctly describe the location of the diversion points and place of use and supersedes certificates of water right recorded at pages 14442 and 14552, Volume 12, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
