## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of PO Box 67, Weiser , State of Idaho 83672 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Snake River

a tributary of Columbia River irrigation of 270.3 acres

for the purpose of

under Permit No. 41976 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 13. 1977

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.19 cubic feet per second, being 4.85 cfs from Diversion Point 1 and 0.34 cfs from Diversion Point 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NW 1/4 SE 1/4), Section 16, Lot 2 (SW 1/4 NW 1/4), Section 17, T15S, R46E, WM; Diversion Point 1-2,000 feet North and 3,460 feet East from SW Corner, Section 16; Diversion 2-1,020 feet South and 2,450 feet West from SE Corner, NE 1/4 NW 1/4, Section 17

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season each year

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.
