## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**GALLAHER FARM COMPANY  
by W.C. GALLAHERof Route 2, Freewater, State of Oregon, has  
a right to the use of the waters of Dugger Creeka tributary of Pine Creek for the purpose of  
irrigation of 120.9 acres, domestic and stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Umatilla County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 321; that the priority of the right thereby confirmed dates from 1890 for 20.1 acres, from 1894 for 12.0 acres, from 1908 for 19.0 acres and from 1900 for 69.8 acres that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 1.52 second feet from May 1 to September 1 of each year, the total quantity diverted during each irrigation season not to exceed 362.7 acre-feet


