CERTIFICATE OF WATER RIGHT

This Is to Certify, That PINE HOLLOW COOPERATIVE, INC.

of Route 1, Box 27, Tygh Valley, State of Oregon 97063, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Three Mile Creek and Pine Hollow Reservoir, constructed under Permit R-6368

a tributary of White River for the purpose of supplemental irrigation of 3,435.5 acres

under Permit No. 39616 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 1, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3,550.0 acre-feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, Section 11, T4S, R11E, WM; Three Mile Creek - 1,530 feet South and 4,580 feet West from NE Corner, Section 11

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year. Water from the reservoir is to provide a supplemental supply for lands being benefitted by exchange of water with lands below the reservoir under the terms of an agreement between the Badger Improvement District and Pine Hollow Cooperative, Inc. and the Pine Hollow Cooperative Water Users agreement. In the exchange, upper lands use water diverted for the lower lands entitled thereto and replace it in like amount from the reservoir and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


