CERTIFICATE OF WATER RIGHT

This Is to Certify, That OSCAR JACOBSON

of North Powder, State of Oregon, has a right to the use of the waters of North Powder River,

a tributary of Powder River, for the purpose of irrigation of 256.5 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Union County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at page 252; that the priority of the right thereby confirmed dates from 1893 for the irrigation of 40.5 acres and 1899 for the irrigation of 216.0 acres

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 6.41 second feet from March 1 to July 1 and 3.21 second feet from July 1 to October 1 of each year; the total quantity diverted during each irrigation season not to exceed 641 acre-feet



The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
