a tributary of Columbia River for the irrigation of 5.6 acres and supplemental irrigation of 3.4 acres

under Permit No. 17226 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from August 5, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 NW4, Section 6, T11S, R26E, WM; 1160 feet South and 1830 feet West from the S $\frac{1}{4}$ Corner, Section 31, T10S, R26E, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be limited to a diversion of not to exceed 1 acre-foot per acre for each acre irrigated during any month and shall be further limited to a total diversion of not to exceed 5 acre-feet per acre for each acre irrigated during the irrigation season from April 1 to September 20 of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.
