## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** GLENN C. BIRDSEYE

of 3793 Rogue River Highway, Gold Hill, State of Oregon 97525, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Birdseye Creek

a tributary of Rogue River for the purpose of irrigation of 76.4 acres

under Permit No. 34894 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 31, 1969 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.96 cubic foot of water per second until July 1 and 0.57 cfs after July 1 of each year

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SE 1/4, Section 34, T36S, R4W, WM; Creek - 80 feet North and 1110 feet East, from S 1/4 Corner, Section 34

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 18.8 acres SE 1/4 NE 1/4 as projected within D. Birdseye DLC 41

- 4.0 acres SW 1/4 SE 1/4 as projected within D. Birdseye DLC 41


