CERTIFICATE OF WATER RIGHT

This Is to Certify, That GLENN, VICTOR AND DAVID BIRDSEYE

of 3793 Rogue River Highway, Gold Hill, State of Oregon 97525, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Rogue River

a tributary of Pacific Ocean for the purpose of irrigation of 36.6 acres and supplemental irrigation of 58.6 acres

under Permit No. 8888 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 16, 1916

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.19 cubic feet per second if available at the original point of diversion; NW 1/4 NE 1/4, Section 11, T36S, R3W, WM; Gold Hill Irrigation District Ditch - North 38 degrees, East 4900 feet from SW Corner, Section 11.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SE 1/4 as projected within D. Birdseye DLC 41, Section 27, T36S, R4W, WM; 1190 feet North and 100 feet West from SE Corner, Section 27

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


An order of the Water Resources Director entered June 12, 1981 canceled a portion of the right described by the Special Order entered on page 353, Volume 28, which also approved a change in point of diversion. This certificate is issued to confirm that point of diversion change for the balance of the right.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
