## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** FISH MILL LODGES, INC.

of Westlake, State of Oregon 97493, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed spring

a tributary of Siltcoos Lake for the purpose of domestic use for 10 houses and a 12 cabin motel

under Permit No. 19784 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from August 18, 1950 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (SE $\frac{1}{4}$  NW $\frac{1}{4}$ ), Section 34, T19S, R12W, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 3 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
Section 34

Township 19 South, Range 12 West, WM

Place of use more explicitly described as: 1 house each on Lots 2, 3, 9, 11, 12 and 13, Block 28; Lots 13 and 19, Block 29; Lots 5 and 6, Block 32, and motel on Lots 5, 6, 7 and 8, Block 28, Plat of Westlake.


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 24307, Volume 17, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on March 7, 1983.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
