## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

J.R. McKY

of PO Box 921, Eugene , State of Oregon , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Coyote Creek

a tributary of Long Tom River irrigation of 29.0 acres

for the purpose of

under Permit No. 20638 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 10, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.36 cubic foot per second, if available at the original point of diversion; NE 1/4 NE 1/4, as projected within H.C. Owens DLC 40, Section 11, T18S, R5W, WM

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NW 1/4 as projected within Owens DLC 40, Section 11, T18S, R5W, WM, 240 feet South and 10 feet East from NW Corner Section 12.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered April 6, 1960 and supersedes certificate of water right recorded at page 24423, Volume 17, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
