CERTIFICATE OF WATER RIGHT

This Is to Certify, That

INDUSTRIAL FORESTRY ASSOCIATION

of 225 Southwest Broadway, Room 400, Portland State of Oregon 97205, has made proof to the satisfaction of the Water Resources Director of a right to the use of the waters of Well 3

a tributary of Molalla River for the purpose of temperature control and irrigation of 28.9 acres

under Permit No. G-7478 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 3, 1977 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.33 cubic feet per second, being 1.33 cfs for temperature control and 0.36 cfs for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 NW 1/4, as projected within Pendleton DLC 58, Section 33, T3S, R1E, WM; 2,660 feet South and 770 feet West from the NE Corner, Pendleton DLC 58

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Section 28
 - 0.1 acre SE 1/4 SE 1/4 as projected within Pendleton DLC 58
Section 29
 - 4.6 acres Lot 1 (NE 1/4 NE 1/4)
 - 4.2 acres SE 1/4 NE 1/4
Section 32
 - 10.9 acres NW 1/4 NW 1/4 as projected within Pendleton DLC 58
 - 5.7 acres Lot 3 (NW 1/4 NW 1/4)
 - 1.2 acres SW 1/4 NW 1/4
Section 33
- Township 3 South, Range 1 East, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
