## CERTIFICATE OF WATER RIGHT

**This Is to Certify,** That M.C. SHELLEY

of Route 1, Box 97, Payette, State of Idaho 83661, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Stinking Water Creek Reservoir constructed under Permit R-5601

a tributary of Malheur River for the purpose of supplemental irrigation of 481.7 acres

under Permit No. 34957 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 15, 1967 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1,169.0 acre-feet stored water only

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, Section 16; SE 1/4 SE 1/4, Section 17, NW 1/4 NE 1/4, Section 20, Township 22 South, Range 35 East, WM; Creek - 650 feet North and 1,300 feet East; 1,900 South and 30 feet West, both from W 1/4 Corner, Section 16; Reservoir - 1,050 South and 600 feet East from N 1/4 Corner, Section 20

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ~~of one cubic foot per second per acre.~~ a diversion of 3 acre-feet for each acre irrigated during the irrigation season of each year and is subject to the terms and conditions of an order of the Water Resources Director entered, February 15, 1962

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


