## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** M. C. SHELLEY

of Route 1, Box 97, Payette, State of Idaho 83661, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Stinkingwater Creek and Stinkingwater Creek Reservoir constructed under Permit R-4609 a tributary of Malheur River for the purpose of irrigation of 243.9 acres and supplemental irrigation of 237.8 acres

under Permit No. 30705 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 12, 1960 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 6.0 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 NW 1/4, Section 16, SE 1/4 SE 1/4, Section 17; NW 1/4 NE 1/4, Section 20, T22S, R35E, WM; Creek - 650 feet North and 1,300 feet East; 1,900 feet South and 30 feet West, both from W 1/4 Corner, Section 16; Reservoir - 1,050 feet South and 600 feet East from N 1/4 Corner, Section 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-4609, and shall be subject to the terms and conditions of an order of the Water Resources Director entered February 15, 1962,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


