under Permit No. U-368 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 26, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.57 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE^1_4 NE^1_4 , Section 21, T39S, R11E, WM; South 03 degrees 21 minutes West, 2326.7 feet from NE Corner, Section 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

This certificate is issued to describe that portion of the water right reinstated by a correcting order of the Water Resources Director entered on April 20, 1983, and supersedes Certificate 46053.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
