CERTIFICATE OF WATER RIGHT

This Is to Certify, That CRISLEY BURGER

of c/o Sheep Mountain Cattle, Co, Loomis, State of Washington 98827, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Middle Fork Twelvemile Creek

a tributary of Twelvemile Creek for the purpose of irrigation of 31.7 acres

under Permit No. 32346 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the rights hereby confirmed dates from February 15, 1967 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.79 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 NW 1/4, Section 29, SE 1/4 NW 1/4, Lot 2 (SW 1/4 NW 1/4), Section 30, T19S, R25E, WM; Diversion 1 - 870 feet South and 40 feet East; Diversion 2 - 1,650 feet South and 3,180 feet West; Diversion 3 - 1,500 feet South and 4,070 feet West, all from NE Corner, Section 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.9 acres NE 1/4 NE 1/4
 3.6 acres SW 1/4 NE 1/4
 3.8 acres SE 1/4 NE 1/4
 5.8 acres Lot 1 (NW 1/4 NW 1/4)
 9.5 acres Lot 2 (SW 1/4 NW 1/4)
 6.1 acres SE 1/4 NW 1/4
 Section 30
 Township 19 South, Range 25 East, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
