CERTIFICATE OF WATER RIGHT

This Is to Certify, That MILDRED POWELL CARTER and
ELBERT R. and NORMA J. MATHER

of PO Box 245, Cottage Grove, State of Oregon 97424, has made
proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of
Powell Creek, Nelson Creek and reservoir constructed under Permit R-6268

a tributary of Umpqua River for the purpose of
irrigation of 1.9 acres, fish culture and domestic use for three families

under Permit No. 39112 and that said right to the use of said waters has been perfected in
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from
November 9, 1973

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
0.045 cubic foot per second, being 0.005 cfs for fish culture, 0.01 cfs for
irrigation and 0.01 cfs for domestic from Powell Creek; 0.01 cfs for
irrigation, 0.005 cfs for fish culture and 0.005 cfs for domestic from Nelson
Creek or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the NW 1/4 SE 1/4, Lot 3 (SW 1/4 SE 1/4),
Section 4, T22S, R8W, WM; Powell Creek - 1000 feet North and 320 feet East;
Nelson Creek - 500 feet North and 500 feet East both from from NW Corner DLC 50

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited
to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre
irrigated during the irrigation season of each year

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right
is appurtenant, is as follows:

POWELL CREEK
Domestic and 0.8 acre


NELSON CREEK
CARTER - Fish culture

MATHER - Domestic and 1.1 acres
Lot 3 (SW 1/4 SE 1/4)
Section 4
Township 22 South, Range 8 West, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place
of use herein described. and is subject to minimum flows established by the Water
Policy Review Board with an effective date prior to this right.
