CERTIFICATE OF WATER RIGHT

This Is to Certify, That

EVERGREEN FARMS

of Route 1, Box 596, Salem, State of Oregon 97304, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well 2

a tributary of Palmer Creek for the purpose of irrigation of 58.7 acres and supplemental irrigation of 48.8 acres

under Permit No. G-5503 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 17, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.0 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NE 1/4 SW 1/4 as projected within Adam Matheny DLC 60, Section 33, T5S, R3W, WM; 300 feet North and 90 feet West from the SW Corner, Daniel Matheny DLC 38

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.8 acre SE 1/4 SW 1/4 as projected within Adam Matheny DLC 60
