proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of
an unnamed spring and unnamed stream

a tributary of Brandy Creek
irrigation of 10.3 acres

for the purpose of

under Permit No. 19466 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 17. 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SW 1/4, as projected within Dimmick DLC 64, Section 35, T4S, RlW, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieths one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, water to be diverted from unnamed stream when available and any deficiency in the available supply to be made up by diversion from unnamed spring, providing the total quantity diverted from both sources shall not exceed 1/80th cfs for each acre irrigated,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Save and except all roads and roadways.

Tract 16 of DIMMICK HOMESTEAD TRACTS in Marion County, State of Oregon, as showns and designated on the duly recorded map and plat thereof on file and of record in Volume 5, page 29, Record of Town Plats for said county and state.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 22760, Volume 16, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on July 18, 1983.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
