CERTIFICATE OF WATER RIGHT

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed one and one-half acre-feet per acre in any 30-day period prior to June 1, one acre-foot per acre in any 30-day period after June 1 of each year, or three acre-feet per acre during any season, diverted at a rate not to exceed one-twentieth of a cubic foot per second per acre; and five cubic feet per second for 120 acres *
