CERTIFICATE OF WATER RIGHT

This is to certify, That DONALD CLARK KEY

of Route 1, Box 1844, Hermiston , State of Oregon 97838 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Wells 1 and 2

a tributary of Umatilla River for the purpose of irrigation of 211.1 acres and supplemental irrigation of 312.1 acres

under Permit No. G-4878 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

March 31, 1970 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.31 cubic feet per second, being 2.155 cfs from each well

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SE 1/4 SE 1/4, Section 30, T4N, R27E, WM; Well 1-290 feet North and 50 feet West; Well 2-100 feet North and 40 feet West, both from the SE Corner, Section 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the completed wells shall not exceed 175 feet in depth, nor appropriate water from an aquifer below that depth,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
