CERTIFICATE OF WATER RIGHT

This Is to Certify, That DONALD E. HERSHISER

of 25152 SW Petes Mountain Road, West Linn, State of Oregon 97068, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a spring, unnamed stream and reservoir, constructed under Permit R-5967 with any deficiency in the available supply from the unnamed stream for fish* a tributary of Willamette River for the purpose of stock, supplemental irrigation of 10.7 acres and fish culture

under Permit No. 36781 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 28, 1972 for spring, August 9, 1972 for stream and reservoir that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic foot per second, being 0.01 cfs for stock, 0.13 cfs for supplemental irrigation from spring and 0.15 cfs for fish culture from stream and reservoir

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NE 1/4 NE 1/4), Section 10, T3S, R1E, WM; Spring - 500 feet North and 1590 East, Dam - 620 feet North and 1510 feet East both from most southerly Corner Weiss DLC 49.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

* culture to be made up by diversion from spring, provided that the total quantity diverted from both sources shall not exceed 0.15 cfs

Fish culture and 2.2 acres SW 1/4 SE 1/4 as projected within Weiss DLC 49
4.3 acres SE 1/4 SE 1/4 as projected within Weiss DLC 49

Stock, fish culture and 2.8 acres Lot 1 (NE 1/4 NE 1/4)
Stock, fish culture and 1.4 acres Lot 11 (NW 1/4 NW 1/4)
Fish culture NW 1/4 NE 1/4 as projected within Weiss DLC 49
Section 10
Township 3 South, Range 1 East, WM

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
