CERTIFICATE OF WATER RIGHT

This is to certify, The CONNECTICUT GENERAL LIFE INSURANCE COMPANY and MERLE F. and MARY LOU CARLSON

910 Stemmons Tower North, Dallas, Texas 75207
of Route 1, Box 50, Boardman, State of Oregon 97818, has made
proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of
Carlson Sump Wells 1 and 2

a tributary of for the purpose of
irrigation of 544.2 acres

under Permit No. G-8619 and that said right to the use of said waters has been perfected in
accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

June 4, 1979
that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is
limited to an amount actually beneficially used for said purposes, and shall not exceed

6.8 cubic feet per second, being 4.0 cfs from Sump Well 1 and 2.8 cfs from
Sump Well 2

or its equivalent in case of rotation, measured at the point of diversion from the well. The well is
located in the SE 1/4 NE 1/4, Section 10, T4N, R25E, WM; Sump 1 -
1300 feet North and 440 feet West; Sump 2 - 1250 feet North and 100 feet West,
both from E 1/4 Corner, Section 10

The amount of water used for irrigation, together with the amount secured under any other right
existing for the same lands, shall be limited to one-eightieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited
to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated
during the irrigation season of each year, and shall be further limited to
appropriation of water only to the extent that it does not impair or
substantially interfere with existing surface water rights of others,

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:

In processing the application towards issuance of the permit, it appears that a clerical error was inadvertently made in limiting the duty of water to not exceed one-eightieth of one cubic foot per second per acre and 5 acre-feet per acre. In the issuance of this certificate, the duty of water has been reduced to one-eightieth cfs per acre, and 3 acre-feet per acre for each acre irrigated during the irrigation season of each year, in keeping with the customary policy and determination of this office of the proper maximum limits.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
