CERTIFICATE OF WATER RIGHT

This Is to Certify, That

PHILIP OLSON

of 6750 Bethel Road, Rickreall, State of Oregon 97371, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Unnamed drainageway and reservoir, constructed under Permit R-6642

a tributary of Ash Swale for the purpose of supplemental irrigation of 258.0 acres

under Permit No. 41972 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 30, 1977 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 3.23 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SW 1/4 as projected within Allen DLC 47, Section 33, T5S, R4W, WM; 1860 feet North and 1450 feet East from SW Corner, Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R-6642, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 6.5 acres SE 1/4 NE 1/4
- 6.7 acres SW 1/4 NW 1/4
- 1.0 acre SE 1/4 NW 1/4
- 30.0 acres NE 1/4 SW 1/4
- 24.6 acres NW 1/4 SW 1/4
- 29.9 acres SW 1/4 SW 1/4
- 29.7 acres SE 1/4 SW 1/4
- 33.2 acres NE 1/4 SE 1/4
- 39.2 acres NW 1/4 SE 1/4
- 38.8 acres SW 1/4 SE 1/4
- 13.2 acres SE 1/4 SE 1/4
