CERTIFICATE OF WATER RIGHT

This is to certify, That ROGUE RIVER NATIONAL FOREST

, State of Oregon 97501 of PO Box 520, Medford , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of subsurface drainage for the purpose of a tributary of Jackson Creek supplemental irrigation and frost control of 221.3 acres under Permit No. G-8624 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 23, 1979 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.0 cubic feet per second, being 2.0 cfs for supplemental irrigation and 2.0 cfs for frost control or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the SW 1/4 NW 1/4, Section 15, T37S, R2W, WM; 1970 feet South and 1110 feet East from NW Corner, Section 15.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
