CERTIFICATE OF WATER RIGHT

This Is to Certify, That

DERALD and LINDA WALKER

of Route 1, Box 28, Tygh Valley, State of Oregon, 97063, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of an unnamed stream, Lost Creek, Boulder Creek and Forest Creek

a tributary of White River for the purpose of irrigation of 97.61 acres

under Permit No. 40276 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 15, 1976

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.41 cubic feet per second; being 0.86 cfs from unnamed stream, 0.18 cfs from Lost Creek, 0.18 cfs from Boulder Creek, and 0.19 cfs from Forest Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SW 1/4, Section 5, T5S, R12E, WM, Unnamed Stream - 1420 feet North and 310 feet West from S 1/4 Corner, Section 5; SE 1/4 SW 1/4, Section 26, NE 1/4 SE 1/4, SW 1/4 SW 1/4, Section 27, T4S, R10E, WM; Lost Creek (Lost and Boulder Ditch)- 1310 feet North and 1740 feet East, Boulder Creek - 2340 feet North and 350 feet West *

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- * both from SE Corner, Section 27, Forest Creek - North 57 degrees 02 minutes East 282 feet from SW Corner, Section 27.
