under Permit No. 31786 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.78 cubic foot per second, being 0.22 cfs for irrigation and 0.56 cfs for cranberry harvesting

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4 SE 1/4, SE 1/4 SW 1/4, Section 7; NE 1/4 NW 1/4, Section 18, T29S, R14W, WM; Creek - 490 feet North and 1360 feet East; Reservoir 1 - 200 feet North and 1050 feet West; Reservoir 2 - 220 feet South and 500 feet West, all from S 1/4 Corner, Section 7

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre-feet per acre for each acre irrigated during the irrigation season of each year for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to one-eightieth of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2acre-feet per acre for each acre irrigated during the irrigation season of each

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
