

## CERTIFICATE OF WATER RIGHT

This Is to Certify, That MARGARETHA & F.C. NOOTNAGLE and J.W. BERRY

of Sisters , State of Oregon 97759 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Cold Springs, Trout Creek and Nootnagle Reservoir, constructed under Permit R-381 a tributary of Squaw Creek for the purpose of irrigation of 280.0 acres and supplemental irrigation of 180.0 acres

under Permit No. 3143 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 29, 1916

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 5.56 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
