## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**

ALFRED J. JR. and NANCY GETTYS

of PO Box 468, Glide, State of Oregon 97443, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Fall Creek

a tributary of Little River for the purpose of irrigation of 4.3 acres

under Permit No. 20687 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 22, 1951

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second; if available at the original point of diversion, SW 1/4 SE 1/4, Section 32, T26S, R3W, WM; 1060 feet North and 350 feet East from the S 1/4 Corner, Section 32

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SE 1/4, Section 32, T26S, R3W, WM; 1450 feet South and 2200 feet West from E 1/4 Corner, Section 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.3 acres SW 1/4 SE 1/4  
Section 32  
Township 26 South, Range 3 West, WM

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered October 30, 1978 and together with orders of the Water Resources Director entered February 7, 1968 and October 5, 1978 supersedes Certificate of Water Right recorded at page 23565, Volume 17, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
