or its equivalent in case of rotation, measured at the point of diversion from the well. The well is located in the NW 1/4 SE 1/4 as projected within Walker DLC 57, Section 1, T7S, R4W, WM; 110 feet North and 30 feet West from Easterly SE Corner, Lot 8 of Pioneer Park Addition 1
The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre, This right shall be limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.
