CERTIFICATE OF WATER RIGHT

This is to certify, That MELVIN E. KING

, State of Oregon 97381 of 4285 Desart Road, N.E., Silverton , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of one well a tributary of Pudding River for the purpose of Supplemental irrigation of 12.0 acres and irrigation of 88.0 acres under Permit No. G-6307 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 30, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.7 cubic foot per second or its equivalent in case of rotation, measured at the point of diversion from the well. The well is NE 1/4 NW 1/4, as projected within McAllister DLC 49 Section 18, T7S, R1W, WM; 610 feet South and 1,850 feet East from NW Corner Section 18 . The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.
