CERTIFICATE OF WATER RIGHT

This Is to Certify, That

ROSS M. LENT

of Star Route, Azalea, State of Oregon 97410, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Cow Creek

a tributary of South Umpqua River for the purpose of irrigation of 37.8 acres

under Permit No. 27501 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 25, 1961 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.39 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, Section 33, T31S, R4W, WM; 280 feet South and 520 feet East from Center, Section 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-seventieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right to use of water is limited to the period when the flow of Cow Creek is more than 11 cfs at its mouth,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.2 acres SW 1/4 NE 1/4 22.0 acres NW 1/4 SE 1/4
2.6 acres NE 1/4 SW 1/4 Section 33
Township 31 South, Range 4 West, WM

This certificate is issued to correctly describe the location of use and describes that portion of the water right confirmed by the prior certificate recorded at page 36165, Volume 28, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on December 6, 1983, approving Transfer Application 5376.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
