CERTIFICATE OF WATER RIGHT

This Is to Certify, That W. and E. MILLER RANCHES, INC.

of Kimberly, State of Oregon 97848, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Fork John Day River

a tributary of John Day River for the purpose of irrigation of 26.0 acres

under Permit No. 3854 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 12, 1918

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.33 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SE 1/4, Section 3, NW 1/4 NW 1/4, Section 9, T9S, R27E, WM; North 49 degrees East, 3814 feet from SW Corner, Section 3; 1550 feet South and 470 feet West from NE Corner, SW 1/4 SW 1/4, Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eighth of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 39363, Volume 31, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered November 1, 1983 approving Transfer Application 5339, and entered December 28, 1983 approving Transfer Application 5389.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
