CERTIFICATE OF WATER RIGHT

This Is to Certify, *That* ALBERT A. ARENDS

of PO Box 208, Redwood City, State of California, has
a right to the use of the waters of Evans Creek

a tributary of Rogue River for the purpose of
domestic, stock and irrigation of 8.4 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Jackson County, and the said decree entered of record at Salem, in the Order Record of
the WATER RESOURCES DIRECTOR, in Volume 16, at page 523; that the priority of the
right thereby confirmed dates from 1902

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed 0.14 cubic foot
per second.

The point of diversion is located in the NE 1/4 NW 1/4, Section 4, T36S, R4W, WM; Old
Mill Ditch, 470 feet South and 1920 feet East from NW Corner Section 4.

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:

All lying below the Old Mill Ditch
Section 9
Township 36 South, Range 4 West, WM

Commencing at the section corner common to Sections 3, 4, 9 and 10, T36S, R4W, WM, Jackson County, Oregon; thence South 0 degrees 25 minutes East along the section line common to Sections 9 and 10, 776.16 feet; thence South 75 degrees 30 minutes West 462.0 feet to the true point of beginning; thence running South 24 degrees 57 minutes East 602.2 feet; thence South 0 degrees 25 minutes East 248.6 feet; thence East 198.0 feet to the section line; thence South 0 degrees 25 minutes East along said section line 162.0 feet (to a point from which the quarter section corner common to Sections 9 and 10 bears South 0 degrees 25 minutes East 793.3 feet); thence South 75 degrees 30 minutes West 796.0 feet; thence North 10 degrees 00 minutes West 207.5 feet; thence South 76 degrees 00 minutes West 1893 feet, more or less, to the North and South center line of Section 9; thence North along said center line 841.0 feet; thence North 75 degrees 30 minutes East 2265.0 feet, more or less, to the point of beginning.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 32799, Volume 24, State Record of Water Right Certificates, NOT modified by the provisions of orders of the Water Resources Director entered on November 18, 1983, approving Transfer 5291, and on February 2, 1984, approving Transfer 5417.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
