CERTIFICATE OF WATER RIGHT

This Is to Certify, That

of Ogden , State of Utah , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Snake River

a tributary of Columbia River irrigation of 149.4 acres

for the purpose of

under Permit No. 12921 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 3, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.49 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $SE\ 1/4\ NE\ 1/4$, Section 4, T19S, R47E, WM; 2600 feet South and 2410 feet East from N 1/4 Corner Section 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-sixtieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 1.0 acre-foot per acre for each acre irrigated during any 30-day period and shall not exceed a diversion of 4 1/2 acre-feet for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
