CERTIFICATE OF WATER RIGHT

of Box 55, Drewsey , State of Oregon 97904 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Middle Fork Malheur River

a tributary of Malheur River irrigation of 150.1 acres

for the purpose of

under Permit No. 14673 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 8.1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 7.505 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $NE\ 1/4$ SE 1/4, Section 25, T2OS, R35E, WM; 1440 feet North and 780 feet West from the SE Corner, Section 25.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-twentiethof one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 1 1/2 acre-feet per acre for each acre irrigated in any 30-day period prior to June 1, 1 acre-foot per acre for each acre irrigated in any 30-day period after June 1 and shall be further limited to a total diversion of not to exceed 3 acre-feet per acre for each acre irrigated during any irrigation season,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.
