## CERTIFICATE OF WATER RIGHT

This Is to Certify, That

AUSTIN O. SCROGGS

of Route 1, Murphy , State of Oregon 97533 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Scroggs Spring and Maple Gulch, being 0.011 cubic foot per second from Scroggs Spring and 0.008 cfs from Maple Gulch a tributary of Applegate River for the purpose of irrigation of 1.5 acres

under Permit No. 13515 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 13, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.019 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SW 1/4, Section 35, T37S, R5W, WM; Maple Gulch - 30 feet North and 190 feet West, Scroggs Spring - 5 feet North and 195 feet West both from SE Corner, SW 1/4 SW 1/4, Section 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited  $t_{0}$ ne-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.5 acres SW 1/4 SW 1/4

Section 35

Township 37 South, Range 5 West, WM

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 13413, Volume 11, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on October 12, 1978, approving Transfer Application 4019 and together with Loss of Right Order entered March 16, 1984, supersedes Certificate 13413.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
