## CERTIFICATE OF WATER RIGHT

**This is to certify, That** JACK A. WATERS

of Route 3, Box 11, The Dalles, State of Oregon 97058, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a spring and Fifteenmile Creek

a tributary of Columbia River for the purpose of domestic use for one family and irrigation of 5.2 acres

under Permit No. 40325 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

September 4, 1975

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

0.065 cubic foot per second, being 0.005 cfs for domestic from spring, 0.06 cfs for irrigation from Fifteenmile Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 1/4 SE 1/4, Section 31, T2N, R14E, WM, Spring - 680 feet South and 540 feet West; Creek - 450 feet South and 640 feet West both from the E 1/4 Corner, Section 31.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic and 5.1 acres NE 1/4 SE 1/4  
0.1 acre SE 1/4 SE 1/4  
Section 31  
Township 2 North, Range 14 East, WM

This certificate describes that portion of the water right confirmed by the prior Certificate of Water Right recorded at page 47330, Volume 40, State Record of Water Right Certificates, NOT canceled by the provisions of an order of the Water Resources Director entered on March 16, 1984.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to minimum flows established by the Water Policy Review Board with an effective date prior to this right.
