CERTIFICATE OF WATER RIGHT

This Is to Certify, That ANDREW F. LECKIE

of Fossil, State of Oregon 97830, has a right to the use of the waters of John Day River

a tributary of Columbia River for the purpose of irrigation of 175.4 acres

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Grant County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461; that the priority of the right thereby confirmed dates from 1905

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 4.61 cubic feet per second, if available at the original point of diversion; NE 1/4 SE 1/4, Section 5, and NW 1/4 SW 1/4, Section 9, T9S, R25E, WM.

The point of diversion is located in the NE 1/4 SE 1/4, Section 5, T9S, R25E, WM; SE 1/4 SW 1/4, Section 33, T8S, R25E, WM; 1 - 1820 feet South and 4990 feet East; 2 - 450 feet North and 2860 feet East; 3 - 1020 feet North and 2720 feet East; all from NW Corner of Section 5. A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, irrigated from April 1 to September 30; further limited to one acre-foot per acre during calendar month; total of five acre-feet per acre for season.

This certificate describes that portion of the water right confirmed by Certificate 25632 NOT modified by the provisions of orders of the Water Resources Director entered June 4, 1968 and November 18, 1983, and is issued to confirm a change in place of use and points of diversion approved by orders of the Water Resources Director entered June 4, 1968 and January 21, 1980 and together with certificate of water right recorded at page 35286, Volume 27, State Record of Water Right Certificates, supersedes Certificate 25632.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
