of Route 2, Box 134, Dayton , State of Oregon 97114 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of South Yamhill River

a tributary of Yamhill River irrigation of 93.0 acres

for the purpose of

under Permit No. 37625 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

February 20, 1973 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.16 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW 1/4 SE 1/4 as projected within Jessie DLC 79, Section 14, T4S, R4W, WM; 2,400 feet North and 2,360 feet West from SE Corner Jessie DLC 79

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.2 acres NE 1/4 SE 1/4 as projected within Jessie DLC 79
5.7 acres NW 1/4 SE 1/4 as projected within Jessie DLC 79
