CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOYCE STEARNS BARNEY

of PO Box 683, Prineville, State of Oregon 97754, has a right to the use of the waters of Crooked River

a tributary of Deschutes River for the purpose of irrigation of 96.9 acres, stock and domestic use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at page 449; that the priority of the right thereby confirmed dates from 1893

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a reasonable amount for domestic and stock use, and 1.21 cubic feet per second for irrigation from July 1st to September 15th of each year.

This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 586, Volume 1, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered March 26, 1979, approving Transfer Application 3351 and is issued to confirm a change in place of use and point of diversion approved by the same order and together with cancellation orders of the Director entered January 18, 1979 and April 9, 1982, supersedes Certificate 586.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
