CERTIFICATE OF WATER RIGHT

This Is to Certify, That

MRS. ANNA GRAHAM

of PO Box 2135, Heppner, State of Oregon 97836, has a right to the use of the waters of Willow Creek

a tributary of Columbia River for the purpose of irrigation of 63.5 acres, and domestic, (irrigation from March 1st to July 1st of each year)

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Morrow County, and the said decree entered of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 1, at page 73; that the priority of the right thereby confirmed dates from 1884

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.06 cubic feet per second, if available at the original points of diversion: NE 1/4 SW 1/4, SW 1/4 NW 1/4, Section 21, T2S, R26E, WM; 247 feet South and 1,310 feet West, 1,237 feet North and 1,650 feet West, both from Center Section 21 and the Dutton and Clark Ditch.

The point of diversion is located in the NE 1/4 SW 1/4, SE 1/4 NW 1/4, Section 21; SE 1/4 SE 1/4, Section 17, T2S, R26E, WM, 1 - 240 feet South and 1,120 feet West from the Center of Section 21; 2 - 1,950 feet South and 1,490 feet East and 3 - 600 feet North and 680 feet West; both from the SE Corner Section 17. A description of the place of use under the right, and to which such right is appurtenant, is as follows:

- 15.8 acres SW 1/4 SE 1/4
- 4.2 acres SE 1/4 SE 1/4
- Section 17
- 32.0 acres SW 1/4 NW 1/4
- 4.5 acres SE 1/4 NW 1/4
- 4.0 acres NE 1/4 SW 1/4
- 3.0 acres NW 1/4 SW 1/4
- Section 21
- Township 2 South, Range 26 East, WM

This certificate is issued to confirm a change in place of use and points of diversion approved by an order of the Water Resources Director entered September 12, 1977 and supersedes Certificate 204, Volume 1, State Record of Water Right Certificates

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
